All vendors must remove any items or articles that are deemed objectionable by the festival committee.

All applications must be submitted by August 9, 2024. Full payment is due at time of application.

The Two Rivers committee reserves the right to reject any application.

All garbage must be deposited in proper location and containers.

Vendors must be ready and open by 11:30 a.m. and remain open until 6:00 p.m., anyone wishing to stay open longer may do so.

All vendors will be provided with one parking space near the craft area but outside of the festival area. All other vehicles must be removed from festival area by 10:00 am and parked in the general parking area. For safety reasons, no vehicles are allowed inside the festival area until after the close of the festival.

The Two Rivers Festival committee does not supply tables, chairs, or electrical drop cords.

Vendors are to check in at the craft area the day of the festival beginning at 8:00 am. Earlier setup times must be arranged beforehand.
